
REASON FOR BOARD CONSIDERATION:

Mitchell, having received the next highest plurality of the votes cast, has been and is legally elected to said Board for a term of five (5) years; and be it further RESOLVED that after examining the number of votes cast with respect to the 2016-17 Budget, results are 174 yes, 52 no; and be it lastly RESOLVED that, the recorded signatures of each of the members of said Board present on the official Canvass Document, hereto annexed and made a part of this resolution, shall and does hereby certify same.
