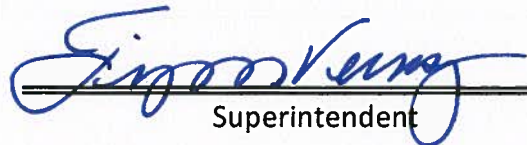
The Budget Status Reports have been prepared by the Cooperative Business Office for the month of April 2016 and the same are hereby presented to the Commissioners for review and acceptance.
