The merger resolution was moved by Blake Gendebien, seconded by Becky Buckingham, and carried with six (6) yes votes and one (1) absent (Davison).

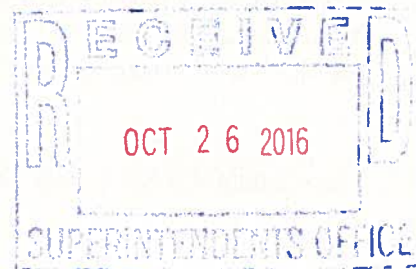


