
FACTS AND ANALYSIS:

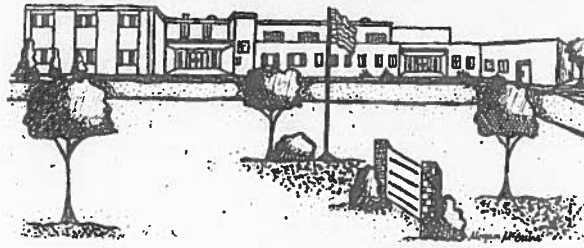

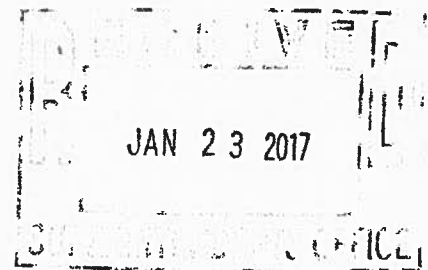

At a regular Board of Education meeting held at 7:00 p.m. on June 9, 2016, the Lisbon Board of Education approved a resolution to petition the Ogdensburg City School District Board of Education to allow Lisbon Central School boys to participate in interscholastic boys' lacrosse at the modified level for the 2016-2017 season.

The merger resolution was moved by Blake Gendebien, seconded by Nancy Addison, and carried with six (6) yes votes and one (1) absent (Davison).
