Mr. Tessmer and Mr. Bjork were present to provide information on changes since the last review and to answer any other questions or concern brought up by the Board.

The committee met after the last Board meeting to address some concerns about the Academic Eligibility policy. From that meeting it was concluded that the verbaige Pass/Fail would stand, instead of acceptable/unacceptable, and the policy would retain its leveled P1, P2 and suspension system.

M. Tooley reminded those present of this concern about students coming into a sport for a merger possibly not being held to the same standard as OFA students because of their home school's Academic Eligibility policies. Mr. Bjork will provide the board with the Academic Eligibility policies for merger schools so that informed decisions on mergers can take place.
