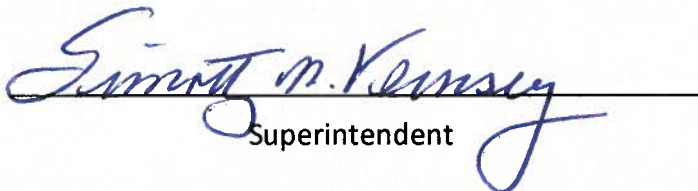
FACTS AND ANALYSIS:
