
FACTS AND ANALYSIS:

At a regular Board of Education meeting held at 6:00 p.m. on February 15, 2018, the Lisbon Board of Education approved a resolution to petition the Ogdensburg City School District Board of Education to allow Lisbon Central School boys to participate in interscholastic boys' lacrosse at the modified level for the 2017-2018 season.

The merger resolution was moved by Becky Buckingham, seconded by Andrea Randle and carried with five (5) yes votes and two (2) absent (McKnight and Walker).
