GUIDANCE DEPARTMENT GRADES 7-12 KATRINA PUTMAN DEPARTMENT HEAD

The purpose of this report is to present an overview of the Guidance services at OFA for the 2018-2019 school year. Mr. Christy and Mrs. Putman serve students in grades 9-12 while Mrs. TenEyck serves students in grades 7-8. The counseling services for our CSE students in grades 7-8 were provided by Mrs. TenEyck; counseling services for students in grades 9-12 were split (alphabetically) by Mr. Christy and Mrs. Putman. The ACCESS-VR (formerly known as VESID) services were coordinated through the high school guidance office for our district students during the 2018-19 school year.

- 4 seniors were awarded NYS Scholarships for Academic Excellence (1@ \$1500/yr;3@\$500/yr).
- 8 seniors received a diploma distinction of "Mastery in Mathematics" and 11 seniors received "Mastery in Science" having earned an 85 or higher in three Regents' exams in each respective discipline. 8 seniors received distinction in both Mathematics and Science.
- 71% of college-bound seniors received scholarships
- 34 seniors were National Honor Society members
- 13 seniors were Business & Marketing Honor Society members
- 6 seniors were Vocational/Technical Honor Society members
- 31 seniors graduated with honors
- 45 seniors received some advanced college credit upon graduating

OTHER HIGHLIGHTS:

In addition to the annual programs our office offers to students and parents including, The College Fair, SUNY Road Show, Junior Information Night, and Financial Aid Awareness Night, the following activities/events occurred this year:

- Mrs. TenEyck helped to organize and coordinate a brand new Transition Day program in June for our 6th graders moving up to 7th grade. Over 3 days, all 6th graders from Madill and Kennedy elementary schools had the opportunity to visit the OFA Middle School to pair up with a current 7th grader and shadow through 4 class periods. The visit also included a question and answer period to help alleviate fears and concerns.
- Through collaboration with United Helper's MOSAIC, a childcare coordinator was placed at OFA one day per week from September-March.
- OFA participated in the Distance Learning Network as a provider. We offered AP and advanced classes to students from Heuvelton (8), Clifton-Fine (3), Lisbon (5), and Morristown (2).
- SUNY Canton came to OFA to assist students with the freshman enrollment process for their school.
- We hosted an interview/career information session for students interested in part-time employment with United Helpers. Students were successfully placed in jobs as a result.
- Identified students for Liberty Partnership Program, Migrant Tutor Program, Youth Advocate Program and for Student of the Month offered by the Greater Ogdensburg Chamber of Commerce.
- All counselors along with OFA staff attended a Staff Development day program on First Aid/CPR and took part in the Active Shooter Drill in the fall. Spring Staff Development included a program at Potsdam State on "Changing With the Times: The New NYSED School Counseling Regulations" and all levels of counselors from Ogdensburg City School District were represented there.
- College Board college search for all Grade 11 and Grade 12 was completed in preparation for the annual College Fair.
- "Gateways to Careers" was attended again this year by the junior class and Northwest Tech seniors. Ms. McLean and Mrs.Putman, along with the Guidance staff, prepared our students for the interview process.
- Mr. Christy and Mrs. Putman attended the NYSFAA Financial Aid workshop hosted locally.
- OFA worked with Claxton-Hepburn Medical Center in an attempt to offer the Health Career Awareness Fair again this year. Unfortunately, C-H was unable to secure enough staff to make the program available this year. We are planning to revisit the program to host in the 2019-2020 school year.
- Mrs. TenEyck continues to run WEB (Where Everyone Belongs) training for peer leaders in grade 8 to assist students transitioning to the middle school.
- All counselors continue to meet almost weekly with Probation for both middle school and high school.

OTHER TASKS AND DUTIES PERFORMED

- Conducted individual senior interviews with parents and students.
- Contacted parents of seniors who failed courses each marking period and facilitated contact between staff and parents to help resolve issues leading to failures.
- Contacted parents of students who had missed three consecutive days of school.
- Scheduled and participated in orientation for incoming grade 7, 8, and 9 students.
- Monitored weekly reports/progress reports/report cards for students.
- Held annual Junior Night for students to meet with college Financial Aid and Admissions representatives. We invited bordering districts to attend.
- Identified and arranged for 23 female students to attend the Women in Engineering Day held at SUNY Canton.
- Reviewed PSAT results with 10th and 11th grade students and set them up to have individualized SAT prep through the College Board and the Khan Academy.
- Coordinated signups for the SLL BOCES SAT/ACT Preparation course, and we enrolled over 15 students in weekend test prep classes.
- Served as school liaison with LPP program, an early college awareness program available for our students who qualify.
- Managed information for all students in Grades 7-12 who receive Academic Intervention Services.
- Reviewed student schedules to ensure students are meeting graduation requirements.
- Met with students who are academically "at-risk" for failure.
- 10th grade visitation to Northwest Tech.
- Visited 8th grade Science class for Grades 9-12 guidance orientation purposes.
- Continued to honor parent requests for tutoring on a case by case basis when possible.
- Referred and coordinated all ACCESS-VR interviews.
- Referred students and parents to outside agencies including Mobile Integration Team (MIT team)
- Coordinated continuation of academic coursework for students who are in institutional settings.
- Attended CSE meetings/annual reviews.
- Attended Superintendent formal and informal hearings.
- Attended attendance hearings for students with Mrs. Tuttle and Mr. Bjork.
- Oversaw and coordinated the administration of testing including SAT, PSAT, ACT, AP, and other testing. Completed required paperwork and administered various standardized tests for students with disabilities as well.
- Assisted the CSE with process for CSE testing.
- Registered students for Scholars Enrichment (SLU) and Project Challenge (Clarkson) enrichment programs.
- Assisted students and families in registering for the NCAA Eligibility Center and maintained the NCAA Core Course Listing for the district.

The list above is not a complete list of duties performed but highlights those that are very important.

We continue to be a test center for the SATs/ACTs in September, October, November, December, January, April, May and June. Over 40 OFA students tested for the SAT I and 15 OFA students for the ACT this year.

For the Class of 2020, we had 45 juniors take the SAT and 15 students take the ACT. Results are listed in the tables below:

As you can see, we were in the average range on both the Evidence-based Reading and Writing and the Math sections. However, our math scores were closer to the State and National Averages.

We were above the National Average in all test areas, except English, where we ranked in the average range. Our students did well on the Reading, Math, and Science subtests.

PSAT'S were administered in October 2018 for Class of 2020. We tested 57 students (48 in grade 11 and 9 in grade 10): We report an average score of 505 in Evidence-Based Reading & Writing and 531 in Math. A score of 500 is considered an average score. 73% of our students met the benchmark for college and career readiness in ELA, 52% met the benchmark in Math and 44% met the benchmark for both.

OFA students continue to participate in the Advanced Placement testing program. Mr. Christy served as the testing coordinator. Listed below are the numbers for the 2018-2019 school year:

The College Board recommends that college credit be awarded for a score of 3 or higher however each college may have its own policy regarding the awarding of credit.

We also continue to have students participate in a dual enrollment program offered by SUNY Potsdam (Spanish and French IV), Paul Smith's College (Calculus I, Pre-Calculus, Advanced Algebra, Statistics, and Accounting), and St. Lawrence University (Spanish V). These agreements continue to help our students make a successful transition from high school to college and for many, give them the confidence they need to start college knowing they have already successfully completed a college level course.

We had 2 students who took and successfully passed the TASC exam this year through the Northwest Tech program.

With regard to professional development, we continue to have the support of the district to attend many workshops related to our profession. Workshop topics attended this year included:

- Mental Health Symposium (two-day conference) offered by Jefferson-Lewis BOCES and community agencies.
- "When Grief Comes to School After a Suicide" workshop at Hospice of the St. Lawrence Valley.
- "High In Plain Sight" presentation offered at SLU to educate school employees and law enforcement employees about current drug trends.
- 2018-19 NYS Financial Aid School Counselor workshop.
- Our Fall staff development day was spent here at OFA completing First Aid/CPR training and participating in the Active Shooter Drill with area law enforcement and emergency responders.
- Our Spring Staff Development Day was spent at SUNY Potsdam learning about the new NYSED School Counseling Regulations.
- "Tomorrow's Workers: Closing the Middle Skills Gap" offered by the North Country STEM Network in partnership with the Jefferson-Lewis Workforce Development Board and the Workforce Development Institute.
- "Integrating Threat Assessment and Management into School Systems" offered at SUNY Potsdam to help us develop a team/plan/protocol to respond appropriately to various situations.
- "Eastern NY Community Schools Regional Meeting" to learn about the community schools initiative and how to move forward if we so choose.
- "Summit on Mental Health Education in NYS Schools" in Lake Placid.

In addition to educational advisement, the school counselors continue to provide psychoemotional counseling services to our student population.

This year, we continued to work with a number of students who were afflicted with alcohol, substance abuse, and mental health issues. This year, more so than in past years, we worked with the St. Lawrence County Probation and the St. Lawrence Children and Youth services. We continue to see a rise in the need for intensive case management services; more students are in need of more services.

Furthermore, issues that we are confronted with on a regular basis include many mental health issues, including students presenting with very high levels of anxiety. This seems to be our number one issue. Mental health needs, along with social anxiety, affect many of our students who may end in placement at SLPC or on home tutoring. We worked very closely with the education program at SLPC to keep our students on track during their absence. This year was average to above average in terms of numbers of students who were temporarily receiving instruction through SLPC or other inpatient placements. Other issues include family problems, divorce and separation, relationship issues, and physical and sexual abuse. CPS hotline calls and PINS referrals were made as situations warranted it. While we provide brief treatment to our students and families, probably even more importantly, we serve as a community referral resource.

Overall, we had a very successful year. We are very sad to say good-bye to Dick Christy who served our 9-12 grade students well for the past 24 years, but we welcome the return of Lynnette VanTassel as a 9-12 counselor.

Our goals for next year include:

- Update our Guidance Office home page with more useful and relevant information for families and students.
- Look for opportunities to use social media more effectively to communicate with students and families. We have used email, but would like to venture into the option of group texting important reminders through an app.
- Continue to seek programs that will assist our students with transitions to post-secondary education opportunities and how to finance them.
- Increase positive communication and engagement with families and students.

Many of the things that are followed up on are: allergies, medications, activity restrictions, immunization compliance, vision and hearing referrals. There is continuous follow up with phone calls and letters home, especially with immunization compliance, hearing and vision referrals. Follow up on mandated immunizations has been very time consuming due to increased regulations and many are constantly changing. Many phone calls to NY State Public Health and Collaboration with St. Lawrence County Public Health Nurses to assure all students are properly immunized. Time has been spent collaborating with NYS Health Services and Child Protective Services on several students. Time has been spent on phone with NY State Center for School health discussing various situations that have arisen this year such as specific medications on Field trips and supervision of special needs children, transportation of special needs students during evacuation and drills, etc.
