Resolution to Approve the Memorandum of Agreement with the St. Lawrence County Board of Elections

The board will be asked to approve the MOA with the St. Lawrence County Board of Elections to allow the district to use their voting machines, equipment and their assistance with the district Annual Budget Vote and School Board Election on May 19, 2020.

Standard Work Day and Reporting Resolution

The New York State Retirement system has a new regulation enacted as of August 2009, which requires employers to report the Standard Work Day for elected or appointed officials who are members of the New York State Employee Retirement System. The elected or appointed officials are required to record the time worked outside the normal working day. The resolution included is the worksheet that NYS requires employers to complete and the resolution must be posted on our website for 30 days after the board approves it. The resolution and the Affidavit of Posting must be sent to the New York State Comptroller's office within 45 days of board approval.

Resolution to Nominate a Candidate to Fill a Vacant Seat on the St. Lawrence-Lewis Counties BOCES Board

The board will be asked to approve a resolution to nominate Craig Lalonde to fill a vacant seat on the St. Lawrence-Lewis Counties BOCES Board.
