REVENUE ANTICIPATION NOTE RESOLUTION Dated: March 15, 2021

RESOLUTION DELEGATING TO THE PRESIDENT OF THE BOARD OF EDUCATION OF THE ENLARGED OGDENSBURG CITY SCHOOL DISTRICT THE POWER TO AUTHORIZE THE ISSUANCE OF AND TO SELL REVENUE ANTICIPATION NOTES OF SAID DISTRICT IN ANTICIPATION OF THE RECEIPT OF STATE AID.

BE IT RESOLVED, by the Board of Education of the Enlarged Ogdensburg City School District, St. Lawrence County, New York, as follows:

<u>Section 1</u>. Pursuant to Sections 30 and 56 of the Local Finance Law, the power to authorize the issuance of and to sell revenue anticipation notes of the Enlarged Ogdensburg City School District, St. Lawrence County, New York, including renewals thereof is hereby delegated to the President of the Board of Education, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner as may be determined by said President of the Board of Education, pursuant to the Local Finance Law.

<u>Section 2</u>. The authorization contained in this resolution shall be valid for a period of ten years, expiring on March 15, 2031. This resolution shall take effect immediately.
