Resolution Determining that Capital Outlay Project at John F. Kennedy Elementary School is a Type II Action

- 1. The District has determined that the Project constitutes a "Type II action" (as the quoted term is defined in the Regulations) because it falls clearly within the ambit of three actions included on the Type II list specified in Section 617.5 of the Regulations:
  - (a) "routine activity of an educational institution" (617.5(c)(8)); and/or

- (b) "maintenance or repair involving no substantial changes in an existing structure or facility" (617.5(c)(1)); and/or
- (c) "replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site;" (617.5(c)(2)); and
- 2. The Project is not subject to further review under SEQRA; and
- 3. Notwithstanding that the Project is not subject to further review under

SEQRA, the District will continue to comply with the New York State Education Department Guidelines for School District Implementation of the State Environmental Quality Review (SEQR) and Associated Changes in the SED Building Permit Process, which requires consultation with the New York State Office of Parks, Recreation and Historic Preservation; and

Resolution to Approve Propositions to be Voted on by the Voters of the Ogdensburg City School District at the Annual Meeting and School Board Election on May 17, 2022

**RESOLVED:** Section 1. The Project does not exceed thresholds established under 6 NYCRR Part 617, State Environmental Quality Review Act, (SEQRA). The regulatory bases are Section 617.5(c)(1): "maintenance or repair involving no substantial changes in an existing structure or facility" Section 617.5(c)(2): "replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site .... "and Section 617.5(c)(8): "routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area.

Accordingly, the Project is not subject to review under SEQRA.

<u>Section 2.</u> The propositions hereinafter set forth is hereby authorized to be submitted for the approval of the qualified voters at the annual school district election to be held in said District on May 17, 2022.

<u>Section 3.</u> The District Clerk is hereby authorized and directed to include as a part of the notice of the Annual Meeting the propositions in substantially the following form:

# PROPOSITION

(Capital Reserve Fund)

Shall the Board of Education of the Board of Education of the Enlarged Ogdensburg City School District, be authorized to establish a Capital Reserve Fund for a ten-year term pursuant to Section 3651 of the Education Law to be titled "2022 Capital Reserve Fund" and fund such reserve in an amount not to exceed \$10,000,000, inclusive of accrued interest and other investment earnings, to be used for renovations and additions to all District facilities, including purchase of equipment, technology upgrades, classroom equipment and/or school infrastructure

equipment, site development, athletic fields, storm and sanitary sewer, driveways, and parking lots, such reserve fund to be funded from (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ended June 30, 2022 and each fiscal year thereafter for the term of the reserve fund, (ii) transfers of excess monies from Board of Education designated reserves, (iii) amounts from budgetary appropriations from time to time, and (iv) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law?

### **PROPOSITION**

(John F. Kennedy Elementary School)

Shall the Board of Education of the Enlarged Ogdensburg City School District, be authorized to undertake a project consisting of the reconstruction of John F. Kennedy Elementary School at a maximum cost of \$3,000,000 including related site improvements, original furnishings, fixtures and equipment, architectural fees, and all other costs incidental to such work (the "Project") and pay for the costs of the Project by using \$3,000,000 from the capital reserve fund approved by the District voters on May 18, 2021.

<u>Section 4.</u> This resolution shall take effect immediately.
