## PILOT CONSENT RESOLUTION (Wadhams Solar, LLC Project)

A regular meeting of the Board of Education (the "Board of Education") of the Ogdensburg City School District (the "District") was convened on <u>August 23, 2021</u> at <u>6:00 p.m.</u>

The following resolution was duly offered and seconded, to wit:

RESOLUTION OF THE OGDENSBURG CITY SCHOOL DISTRICT CONSENTING TO A PROPOSED PILOT AGREEMENT BY THE ST. LAWRENCE COUNTY INDUSTRIAL DEVELOPMENT AGENCY WITH RESPECT TO A CERTAIN PROJECT (AS DESCRIBED BELOW) TO BE UNDERTAKEN BY WADHAMS SOLAR, LLC AND AUTHORIZING THE DISTRICT PRESIDENT TO EXECUTE AND DELIVER A CERTIFICATE IN FURTHERANCE OF SAME

WHEREAS, WADHAMS SOLAR, LLC, a Delaware limited liability company (the "Company"), has requested the assistance of the St. Lawrence County Industrial Development Agency (the "Agency") with a certain project (the "Project") consisting of (A) the acquisition of an interest in an approximately 38 acre portion of an approximately 197 acre parcel of land located at 6866 State Route 37, Town of Oswegatchie, St. Lawrence County, New York (such portion being hereinafter referred to as the "Land"); (B) the installation on the Land a 4.75 mW-AC ground-mounted photovoltaic solar energy system including panels, racking, inverters, electrical cables, grid interconnection, site preparation, access roads and any other required improvements (collectively, the "Improvements") (C) the acquisition and installation in and around the Improvements of certain items of machinery, equipment, fixtures, furniture and other incidental tangible personal property (collectively, the "Equipment", and together with the Land and the Improvements, the "Facility"); and (D) the lease of the Issuer's interest in the Facility back to the Company pursuant to a project/leaseback agreement; and

WHEREAS, pursuant to the Application for Financial Assistance (the "Application") submitted by the Company to the Agency, the Project will (i) entail a capital investment of approximately \$7,303,913.70; (ii) create an estimated 30 construction jobs; and (iii) create 0 part time jobs; and

WHEREAS, the Agency's Uniform Tax Exemption Policy provides that sponsors of non-industrial projects and projects whose terms deviate from the standard must secure the consent of local taxing jurisdictions in order to structure the terms of a payment in lieu of tax agreement (the "PILOT Agreement"); and

WHEREAS, in connection with the Application, and in furtherance of the Project's positive financial impact within the District and the County of St. Lawrence, the Company has requested the District's support and consent in establishing the terms of the PILOT Agreement as outlined below.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE DISTRICT AS FOLLOWS:

Section 1. The District hereby authorizes the Agency and the Company to enter into the PILOT Agreement, with the estimated payments to be made by the Company under the PILOT Agreement being more particularly described in Schedule A attached hereto.

Section 2. The President of the Board of Education is hereby authorized to execute and deliver a consent certificate (the "Certificate") in the form attached hereto, such Certificate to be delivered to the Agency as evidence of the District's consent to enter into the PILOT Agreement.

<u>Section 3</u>. This resolution shall take effect immediately.
