WHEREAS, both Senate Bill S4810 and Assembly Bill A5276 have now been amended to exclude property owned by Ogdensburg Bridge & Port Authority in the City of Ogdensburg, and

WHEREAS, the Ogdensburg PILOT Task Force met on May 3, 2023 and has made a recommendation to support the amended Bills.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE DISTRICT AS **FOLLOWS:**

> **RESOLVED** that the Ogdensburg City School District supports and encourages the State Legislature to adopt Senate Bill S4810A and Assembly Bill A5276A during the 2023 Legislative Session, and
