Dear Mr. Mitchell,

I am writing to inform you that I have successfully completed the fire inspections for all of the buildings within the district. It is now essential for the district to notify the public and the fire department as to the time and date of the inspection. All identified violations must be documented in the portal no later than September 1, 2023.

As a reminder, it's important to note that certain household items are not suitable for use within school premises. To address this concern, districts might consider reinforcing the policy among staff, urging them not to bring such store-bought items onto the school grounds. The district encompasses various decorative light strings, lamps, as well as carpets, warranting our attention.

## • Decorative light strings

- O All electrical devices and equipment must be listed by a nationally recognized testing laboratory (e.g. UL) and installed and operated in accordance with the manufacturer's instructions
- Seasonal and holiday light strings are listed to UL 588 and are intended for temporary installation and use up to 90 days. The temporary use restriction will be printed on the listing label and in the manufacturer's instructions.
- Light strings listed for year-round use are also available. These devices will be listed to either UL 2388 (for flexible rope lighting) or to UL 588, Supplement SD (for light strings)

## • Carpets and Rugs

o NYSED Manual of Planning Standards requires that all carpets and rug backings must meet the minimum Critical Radiant Flux (CRF) of 0.45 Watts/cm2."
