PROPOSITION

For the purpose of receiving an additional ten percent (10%) in New York State Education Department building aid, shall the Board of Education of the Ogdensburg City School District have approval to: (1) embark upon an energy savings improvement project for the supply and installation of improvements which include LED lighting throughout the District, updating HVAC systems and controls, building envelope improvements, and turf field stadium lighting improvements which are energy conservation measures as authorized by Article 9 of the Energy Law and the Regulations of the Commissioner of Education §155.20, under an energy performance contract at a maximum aggregate cost of \$5,000,000.00; (2) expend such sum for such purpose as appropriated from time to time by the Board of Education taking into account State aid; and (3) enter into an energy performance contract and related financing documents in the principal amount not to exceed \$5,000,000.00.

BE IT FURTHER RESOLVED, that the District Clerk is hereby authorized and directed to include notice of such proposition in the notice of the special School District meeting.
